## Lidl Plus Spin & Win - Terms & Conditions - IE

# **Conditions of Participation in Spin & Win**

## 1. Purpose of the feature

<u>Lidl Plus contains a feature called Spin & Win, which is only accessible to registered Lidl Plus members. In order to use Spin & Win, you must:</u>

- Be a registered Lidl Plus user. You can download the Lidl Plus app from the "App Store" or "Google Play Store".
- Set your Lidl Plus country to Ireland.
- Be of a minimum of 18 years of age.
- Complete a qualifying transaction at a selected Lidl store in the Republic of Ireland.
- Some products are excluded from qualifying for a Spin & Win such as lottery, newspapers, medicines, gift cards, infant milk formula, mobile top-up, checkout bags, alcohol products and deposits paid on items included in the Deposit Return Scheme.

## 2. Participation

By using Spin & Win, you agree to Lidl's terms and conditions for Spin & Win.

Spin and Win is promoted by Lidl Ireland GmbH ("Promoter"), Main Road, Tallaght, Dublin 24.

- To participate, you must identify yourself as a Lidl Plus customer at the checkout during the payment process by scanning your Lidl Plus card.
- In order to qualify for a Spin & Win wheel, you must make a qualifying transaction. Excluded products listed at point 1 above will not count towards a qualifying transaction.
- After each qualifying transaction, you will automatically receive a Spin & Win
  wheel via the Lidl Plus app. Please note that you will only receive one Spin & Win
  card per day i.e. if you complete two transactions within 10 hours you will only
  receive one Spin & Win wheel.
- Spin & Win wheels have a specific validity period which is displayed on the gift coupon and if unused after this date, they will disappear from your Lidl Plus app.

- Once you open the Spin & Win wheel, a digital wheel appears with important information in relation to Spin & Win.
- The wheel field reveals the gift which should then be saved. You can then find this in the "Lidl Treats" section of the Lidl Plus app.
- When a Spin & Win card has expired, it automatically disappears from the view and will not be redeemable.

## 3. Coupons

Only Lidl Plus app users who meet the entry criteria and make a qualifying transaction are eligible for a Spin & Win wheel (Qualifying Participants). Qualifying Participants can enjoy Spin & Win with the fun of knowing you will win a gift every single time! There is no element of lottery or luck, we believe in rewarding everyone, every time!

Spin & Win gifts include free products and percentage discounts.

These discounts are displayed to the user as a coupon in the "Lidl Treats" section of the Lidl Plus app and are subject to the following redemption criteria:

- Redeemable only in selected Lidl stores the Republic of Ireland. Excludes Northern Ireland.
- These stores are: Lidl Swords, Lidl Celbridge, Lidl Mullingar Dublin Road.
- The coupon can only be redeemed on the next purchase (not on the purchase which triggers Spin & Win).
- The coupon must be activated and redeemed during the specified validity period. See individual coupons for terms and conditions.
- The coupon is non-transferable, non-exchangeable and no cash alternative will be offered.
- If the coupon value is higher than the purchase amount, the difference is forfeited by the user and is non-refundable. The balance will not be given in cash.
- Spin & Win coupons can not be redeemed against purchases already made.
- Screenshots, pictures or online printouts of coupons will not be accepted.

## 4. Notification

If a Spin & Win prize is issued to you, it will appear on the home screen.

The Spin & Win gift is revealed immediately after you've spun the wheel. Gift details will be in the "Lidl Treats" section of the app after the user clicks "Save" once the Spin & Win wheel is spun.

Lidl may from time to time use push notifications that you can enable to receive a notification on your device that you have a Spin & Win card available to use via the Lidl Plus app.

# 5. Liability

Each participant in the feature understands and accepts that Lidl is not liable for, and cannot be held liable for, errors, losses and irregularities that may arise when the information is sent, if these are caused by disruption or by any other error or omission arising from problems in telecommunications, data traffic, congestion or internet connection, or for any other reason that is not attributable to Lidl.

Lidl shall not be responsible for any loss, injury, damage or disappointment suffered to participants as a result of their participation in Spin & Win and liability is excluded to the maximum extent permissible by law.

#### 6. Exclusion

Participation in Spin & Win by groups of individuals, automatic services or professional services is not permitted.

Lidl reserves the right to deem any participant ineligible to redeem a coupon awarded in Spin & Win if in its sole view it believes that these terms and conditions or the spirit of the giveaway have been contravened.
