

## **Lidl Plus Digital Vouchers, Lidl Pottery Road, Dun Laoghaire, Dublin, Republic of Ireland - Terms & Conditions**

### **1. Overview**

Lidl Ireland GmbH, Main Road, Tallaght, Dublin 24 is sharing Lidl Plus digital monetary vouchers to customers who had Lidl Pottery Road, Dun Laoghaire, Dublin, Republic of Ireland selected as their favourite store as of Sunday 04.01.2026. These digital monetary vouchers will be valid from Monday 05.01.2026 to Sunday 08.02.2026.

### **2. Eligibility**

The digital monetary vouchers are only accessible to registered Lidl Plus members who had Lidl Pottery Road, Dun Laoghaire, Dublin, Republic of Ireland selected as their favourite store as of Sunday 04.01.2026. To use the digital monetary vouchers, you must:

- Be a registered Lidl Plus user. You can download the Lidl Plus app from the "App Store" or "Google Play Store".
- Set your Lidl Plus country to the Republic of Ireland in the app.
- Be of a minimum of 18 years of age.
- Had "Lidl Pottery Road" selected as your favourite store in the Lidl Plus app, as of Sunday 04.01.2026.
- Activate the digital monetary voucher before going to the till.
- Scan your Lidl Plus card at the till to redeem the digital monetary voucher.
- Digital vouchers can only be redeemed in the following stores;
  1. Lidl Deansgrange
  2. Lidl Glenageary
  3. Lidl Shankill
  4. Lidl Stillorgan
- Complete a qualifying transaction at Lidl Deansgrange, Lidl Glenageary, Lidl Shankill or Lidl Stillorgan.

### **3. Digital Vouchers**

- From Monday 05.01.2026 5 (five) digital monetary vouchers will be available in the "Coupons" section of the Lidl Plus app for customers who had Lidl Pottery Road selected as their favourite store as of Sunday 04.01.2026, and since selected one of Lidl Deansgrange, Lidl Glenageary, Lidl Shankill or Lidl Stillorgan as their store in the Lidl Plus app.
- Each digital voucher will offer the customer €10 off a minimum spend of €50 or more, minus standard exclusions.
- One voucher will be available to use every 7 days from Monday 05.01.2026 - Sunday 08.02.2025.
- Customers must redeem all 5 digital vouchers, starting from week commencing Monday 05.01.2026 to avail of the full "€50" saving that is advertised.
- Some products are excluded from qualifying for the minimum spend of €50 to avail of the €10 discount on the digital vouchers such as alcohol, lottery, newspapers, medicines, gift cards, infant milk formula, mobile top-up, checkout bags or DRS deposits.

#### **4. Liability**
