

Lidl Plus Digital Voucher – Jessie Buckley / Jessie, Jessica, Jess, Jessy, Jesse or Jessi registered name - Terms & Conditions

1. Overview

Lidl Ireland GmbH, Main Road, Tallaght, Dublin 24 is sharing a Lidl Plus digital monetary voucher with customers with the full name “Jessie Buckley” or first name “Jessie”, “Jessica”, “Jess”, “Jessy”, “Jesse” or “Jessi” to spend from Monday 16/03/2026 until Sunday 22/03/2026 in all Lidl stores in the Republic of Ireland.

2. Eligibility

The digital monetary voucher is only accessible to Lidl Plus members registered with the full name “Jessie Buckley” or first name “Jessie”, “Jessica”, “Jess”, “Jessy”, “Jesse” or “Jessi” as of 00:00 am Friday 06/03/2026. To use the digital monetary vouchers, you must:

- Be a registered Lidl Plus user. You can download the Lidl Plus app from the "App Store" or "Google Play Store".
- Set your Lidl Plus country to the Republic of Ireland in the app.
- Be of a minimum of 18 years of age.
- Have registered as the full name “Jessie Buckley” or first name “Jessie”, “Jessica”, “Jess”, “Jessy”, “Jesse” or “Jessi”
- Activate the digital monetary voucher before going to the till.
- Scan your Lidl Plus card at the till to redeem the digital monetary voucher.
- Complete a qualifying transaction at a store in the Republic of Ireland.

3. Digital Vouchers

- From Monday 16/03/2026 a digital monetary voucher will be available in the “Treats” section of the Lidl Plus app for customers who have registered as the full name “Jessie Buckley” or first name “Jessie”, “Jessica”, “Jess”, “Jessy”, “Jesse” or “Jessi” in the Lidl Plus app.
- For customers with the full name registered as “Jessie Buckley”, a digital voucher will offer the customer €50 off their next shop, minus standard exclusions.
- For customers with the first name registered as “Jessie”, “Jessica”, “Jess”, “Jessy”, “Jesse” or “Jessi” only, a digital voucher will offer the customer €5 off their next shop, minus standard exclusions.
- The digital voucher will have a specific validity period until Sunday 22/03/2026, which is displayed on the voucher and if unused after this date, they will disappear from your Lidl Plus app.
- Some products are excluded from qualifying for the discount of the digital vouchers such as alcohol, lottery, newspapers, medicines, gift cards, infant milk formula, mobile top-up, checkout bags and DRS deposits.

4. Liability

- Each customer understands and accepts that Lidl is not liable for, and cannot be held liable for, errors, losses and irregularities that may arise when the information is sent, if these are caused by disruption or by any other error or omission arising from problems in telecommunications, data traffic, congestion, or internet connection, or for any other reason that is not attributable to Lidl.
- Lidl shall not be responsible for any loss, injury, damage or disappointment suffered to customers as a result of their use of the digital vouchers and liability is excluded to the maximum extent permissible by law.

5. Early termination

- Lidl reserves the right to amend, cancel or suspend the digital vouchers without notice at any time.

6. Taxes

- Lidl is not responsible for any tax or other liability which may arise to participants in relation to their use of the digital vouchers.

7. General

- Lidl reserves the right to replace the digital vouchers with an alternative of equal or higher value if circumstances beyond Lidl's control make it necessary to do so.

8. Miscellaneous

The recipient of the €50 Jessie Buckley Coupon agrees that in consideration of the voucher coupon and their acceptance of same, the recipient may be required for promotional activity and the recipient agrees to partake in same.
